

RULES & REGULATIONS:

I. MEMBERSHIP

The members of the Governing Body will be minimum seven and maximum twentyone, Any new person is proposed to be inducted as member of the Society, shall apply on the prescribed form and the application shall be considered and scrutinized by the President and Vice President who may accept or reject the same and their decision will be final. On admission, every member shall sign the "Register of Members" maintained by the Society.

2. CATEGORIES OF MEMBERS

3. LIFE MEMBER

In the event of vacancy on account of ill health, demise, insanity or for any other reason, the next legal heir of such member is empowered to nominate the person of his choice and such nominated person will be the member for his life time in the same position of his ward and cannot be

4. Honorary Members

Any person who is eminent scholar, writer and / or specialist in education i.e. technical, non technical and /or professional may be accepted as a honorary member by the Governing Body of the Society.

5. SUBSCRIPTION

All the members of the society shall pay an annual subscription of Rs.100/- per annum latest by 31st March, every year, provided that the Society may exempt a member or members from such

6. GOVERNING BODY: (Formation and Functions)

- The affairs of the Society shall be managed by the Body known as "Governing Body i.e. President, Vice President, Secretary, and Members.
- The members to the Governing Body shall be elected from amongst the members by a majority of votes by the General Body once in a period of three years.
- The name, address and occupation of the members so elected to the Governing Body shall be communicated to the Registrar of Societies within two weeks of its formation.
- The Governing Body shall not stand dissolved merely on account that any of its Member has resigned or otherwise left the Society. In the event of such situation; the next general election.

7. FUNDS VESTED IN THE GOVERNING BODY

8. MEETINGS:

- c) Passing the Annual Budget;

iv) Notice of Meeting:

The notice for the General Body Meeting and the Governing Body Meetings shall be issued to the members concerned 15 days and 5 days respectively in advance.

9. QUORUM:

The minimum number needed to make a quorum to hold the meeting shall be one-third of the total number of members eligible to attend meeting and to vote.

It is, however, provided that if within one hour from the time appointed for meeting, the quorum is not complete, the meeting shall be adjourned to next day at the same place and time and the quorum shall be the members including life members present and they would transect the business for which the meeting was called.

10.. RESOLUTIONS

All the resolutions and decisions at the meetings shall be taken by majority view, and the final approval of the life members.

II. BANK ACCOUNTS:

A bank account shall be opened in the name of the Society and the same shall be operated as per directions of the Governing Body, or on the revised instructions of the Governing Body as communicated from time to time.

12. INSPECTION OF RECORDS:

Every member of the Society has the right to inspect the record of the Society and the Secretary shall grant the necessary permission for the same at all reasonable times

13. ALTERATION IN RULES

Any additions, alterations or omissions in the rules and regulations of the Society shall be effected by a Resolution of the Society by two third of the members present in person and approval by the life members.

14. DISSOLUTION:

- a) Any number not less than 3/5th of the members present at the meeting specially convened for the purpose subject to the approval of the life members may determine that the Society shall be dissolved whether forth with or at any future time then agreed upon.
- b) If on the dissolution of the Society, there shall remain after the satisfaction of its debts and liabilities and property, whatsoever, not impressed with any Society, agreed between the Society and the donor or donors, if same shall not be paid or distributed amongst the members of the Society or any of them but shall be given to the Society (ies) of the same objects nominated by the life members.
